



Release Notes:

OrthoTrac v15.6.0 Practice Management Software

The following is a list of enhancements included and issues addressed in OrthoTrac, a Sensei product, v15.6.0. All fixes are cumulative (each new release contains all new fixes as well as all fixes from the previous release).

It is the office's responsibility to check with any 3rd party application/software companies to ensure that their software is compatible with the new version of DPMS/SQL software being installed. Carestream Dental is not responsible for incompatibility issues with 3rd party vendors.

Enhancements

Diagnosis Code Supported for Electronic Insurance Claim Billing

You can submit electronic insurance claims with associated ICD-10 diagnosis codes when required by the insurance payer (or when it is a medical claim) to ensure that claims are paid correctly and timely.

The ICD-10 codes are included after the end of the Claim Details. Only one ICD record can be submitted per claim. For dental claims, a maximum of four ICD-10 codes can be submitted.

Orthodontic Date of Referral (Wales Only)

For Welsh orthodontic assessment claims (including Assess and Review, Assess and Refuse, and Assess and Appliance Fitted claims), the age of a patient in respect of exemption eligibility and patient charge application is now calculated based on Date of Referral rather than Date of Assessment for claims with a Date of Assessment on or after April 1, 2024.

When Maintenance>Insurance Claim Options>Insurance Type= FP170 Claims, the Part 3 Patient Under 18 Box 1 is auto-populated with an X if the patient is age under 18 at:

- The Date of Referral if the Date of Assessment is April 1, 2024 or later.
- The Date of Assessment\Completion if the Date of Assessment is before April 1, 2024.

Although the **Patient Under 18** box is auto-populated, the user can select or deselect this box if desired. The Date of Referral can be manually added or edited on the claim.

Preventing User From Running Autopayments for Future Payments

OrthoTrac now allows you to prevent users from running autopayments for future payments. The **Allow AutoPayment to Process for Future Date** option is disabled by default, but you can enable it in the eServices Setup window if needed. You can also select how many days in the future that you can run payments for (e.g., 5 days, 60 days, etc.).

If this setting is not enabled, or the selected ending date is farther out than the set allotted number of days in the future, an error message is displayed when you try to process a payment for a future date.





Customer-Reported Defects Fixed/Not Evident in OrthoTrac v15.6.0

The following is a list of issues addressed in OrthoTrac v15.6.0:

- Collections Report for Promises Due does not display the second line of the address or phone number
- Unable to use **Paste this information into appointment** function to copy next appointment information when there is an existing treatment plan
- Total aligner should be more than Last verified upper aligner message when attempting to modify any aligner
