

## Release Notes: WinOMS Version 10.1

### Enhancements

The following is a list of enhancements included and issues addressed in WinOMS v10.1:

#### CDT 2025 Code Updates

The CDT 2025 code set is included in WinOMS 10.1. The update contains 10 new codes, 8 revisions, 2 deleted codes, and 4 editorial changes.

##### Processing the Code Set Update

Only users with the appropriate security level permission can perform this function.

**Note:** The End-User License Agreement (EULA) must be accepted before processing the CDT code update.

**Note:** The list of CDT codes includes oral surgery codes, as well as codes for other types of practices.

To integrate the updated code set into the software:

1. Select **Utilities > CDT Update > Apply CDT Code Changes**. The Confirm Password window is displayed.
2. Type your password and click **Ok**. The ADA CDT Code License Agreement window is displayed.
3. Click **Agree**. The CDT 2025 Code Update window is displayed. The **Add** tab displays the new CDT codes.
4. Select one of the following:
  - **Process Add** to add the new codes to the procedure code table. For each code, click in the Category, Type of Service, and Place of Service columns and make a selection from the drop-down list.
  - **Skip Add** to skip adding the new codes to the procedure code table.
5. Click the **Change** tab. A list of the procedure codes whose descriptions changed in the new CDT code update is displayed. The codes have two descriptions:
  - A 25-character description that applies to the short description field in the procedure code table.
  - A 40-character description that applies to the long description in the procedure code table.
6. Select one of the following:
  - **Process Changes** to apply all description changes.
  - **Skip Changes** to skip updating descriptions in the procedure code table.
7. Click the **Delete** tab. All ADA procedure codes that are obsolete are listed on the **Delete** tab.
8. Select one of the following:
  - **Process Delete** to mark all procedure codes in the list as Inactive. Inactive codes can be used, but they do not display in standard lists.
  - **Skip Delete** to skip changing these codes to Inactive status.
9. Click **Ok**. A window is displayed to print the CDT Code Update Summary report.

#### 2025 ICD-10 Code Updates

The ICD-10 Fiscal Year 2025 diagnostic code set update is included in WinOMS v10.1.

## Defects Fixed

The following defects have been fixed or are not apparent in WinOMS v10.1:

### **Provider State License Does Not Populate When Printing Rx**

A defect that failed to populate the provider's state license number when printing a prescription has been corrected.

### **Issues Saving ePrescription Data Back to WinOMS**

A defect preventing ePrescriptions data from being saved back to WinOMS has been corrected.

### **Appointment Notes Text Cut Off in Scheduler**

A defect causing note text in the scheduler to be cut off instead of wrapping to the next line has been corrected.

### **Configure Other eServices Window Not Displaying**

A defect that failed to display the eServices configuration settings (Tables > eServices > Configure Other eServices) has been corrected.

### **Template Name Field Blank When Editing EMR Snippets**

A defect that failed to display the Template Name selection option when creating or editing a snippet (Tables > EMR Components > Snippets) has been corrected.

### **TODAYSDATE Merge Field Shortens Month to 3 Characters**

A defect that automatically truncated the TODAYSDATE merge field to three characters has been corrected.

### **Anesthesia Record Report Cuts Off Patient Name With An Apostrophe**

A defect in the Anesthesia Record report (Patient > EMR > Anesthesia > Preview/Print) that deleted all the letters in the last name after an apostrophe has been corrected.

### **Procedures Marked "Not Covered by Insurance" Not Posting With Detailed Calculations**

A defect omitting the posting of procedures marked "Not Covered by Insurance" that occurs when Detailed Calculations is selected (Tables > Practice > Practice Preferences > Insurance > Insurance Due Calculation) has been corrected.

### **Payment Manager GetMerchant Call Crash (v10.1)**

A defect in which the Merchant Assignment screen (Billing > Payment Manager > Assign Merchant) is not fully populated when there are too many lines present has been corrected.

### **Send Patient to Dock Notes Reminder Date Default Error**

A defect causing an error in the date field on the note when docking a patient has been corrected.

### **CS Toolkit Appointment Tool Error (v10.0.5.12)**

A defect in the CS Toolkit Appointment Cleanup Tool that returns an error when selecting Appointments by Date has been corrected.

**On Premise Software Crashes When Adding Facilities (v10.0.5.12)**

A defect causing the software to crash when attempting to add or save a facility (Tables > Practice > Service Facilities/Laboratories) has been corrected.

**Scheduler Closes All Days When Trying To Close a Single Day of the Week in Date Range**

A defect in the Scheduler Slot Setup (Scheduler > Setup Scheduler > Slot Setup) that closes all days of the week in a date range when attempting to mark one day as closed has been corrected.

**Unable to Create Copy of a Treatment Plan (v10.0)**

A defect that occurred when trying to create a Treatment Plan by copying an existing treatment plan (Workspace > Treatment Plans > Create Copy) has been corrected.

**Anesthesia Record Report Vital Signs Table Displays Columns Out Of Timed Order**

A defect in the Vital Signs table display of the Anesthesia Record Report (Patient > EMR > Anesthesia > Preview/Print) has been corrected.

**Digital Consents Should Not Save Without a Staff ID Present**

A defect in which a digital consent did not save and display correctly when a staff ID was not entered has been corrected.

**EMR Notes Should Not Save Without a Staff ID Present**

An issue in which an EMR note did not save and display correctly when a staff ID was not entered has been corrected.

**Imaging Security Rights Pop-Up Message**

An issue in which the software failed to display a pop-up message informing a user they do not have security rights for the imaging integration has been corrected.
